\$75,631 AWARDED IN THE FIRST GRANTS CYCLE

The Huron County Community Foundation was ecstatic to grant \$75,631 in our first grants cycle as a new organization. An awards breakfast was held in April, showcasing grants made to 18 area nonprofits, schools, and municipalities. Grants go to meet the greatest areas of need and to projects that will help Huron County thrive.

Highlights included a \$10,000 grant to Firelands Rails to Trails as they continue to connect communities and offer recreation opportunities throughout the county, multiple grants to children's literacy programs like Huron County Imagination Library and Team First Book, a video campaign created by Norwalk Economic Development Corporation with the goal of attracting young workers, grants to enhance public spaces in New London, and several grants to expand arts and cultural offerings via the Firelands Symphony Orchestra and Norwalk Arts Center. Our robust grants process is made possible by unrestricted dollars from the National City Fund, Jerry E. Stover Fund, and the Fund for Huron County. Several Field of Interest Funds were also put to good use, including the Bertha Mead Fund which supports families and children, the American Timber & Steel Fund that promotes increased access to exercise and recreation, and several Funds created by Ralph and Anne Walter with the intention to enhance New London and help it prosper.
